Role Purpose: To be responsible for leading and delivering high quality football and multi-skills sessions across a variety of school and community settings, at the same time identifying and driving new opportunities for the Football in the Community (FiTC) department. You will also play a key role in supporting the execution of the Aston Villa Foundation strategy and Football in the Community departmental business plan.

Main Responsibilities and Accountabilities

- Deliver high quality Football in the Community (FitC) activities for children across a range of ages and abilities, ensuring all coaching activities are delivered to the highest standards.
- Lead the growth and development of FitC programmes in the designated geographical area, including Soccer Schools, Skills Centres, Player Development Centres, and sessions within school-based environments.
- Lead and deliver high quality school sport and extra-curricular coaching sessions, ensuring all activities are delivered to the highest standard.
- Support the Schools Coordinator and Manager in liaising with schools to set session delivery plans and ensure that individual requirements are met in terms of planning and assessment.
- Responsibility for meeting performance targets, setting and meeting budget income and expenditure on designated FitC centres.
- Develop and maintain relationships with key stakeholders and customers to execute a successful FitC
 offer
- Report on impact and outcomes where applicable
- Flexibility to work evenings and weekends where required.
- Any other reasonable duties and responsibilities which your manager or another senior officer of the Foundation asks you to perform.
